AFFIDAVIT OF UNDERSTANDING

I have read, understood and will comply with all terms of the Nicolet Trail Campground rules and regulations. I understand if I violate ANY provision of these rules, I will be subject to fines at the discretion of the Campground Committee with the possibility of the revocation of my permit WITHOUT REFUND. I also understand that I will be subject to a fee set forth by the Campground Committee for parking my trailer/camper on site before April 30th or remaining in the campground after October 31st, unless I have an approved permit for winter use and/or storage. I understand that the first half of the seasonal fee must be paid by or before May 1st and the second and final installment is due by or before June 30th or I can be EVICTED IMMEDIATELY. If payments are not made by the timeline given or if my permit is revoked and I am evicted from my site, I will be given 3 days to remove my camper/trailer and the site will be rented out to the next camper on the list. If the camper/trailer is not moved within the period specified, the City will impound it until fines/fees are paid. I am responsible for all occupants and guests of my site and subject to fees, fines or even eviction should they violate any of the rules and regulations listed. I will mail back this form, signed and dated as proof of my understanding and make a copy of the same to keep as my records.

INFORMATION

Registration:

All campers must be registered at City Hall and be given their designated site before entering the campground. Daily through monthly rates must be paid at the time of the application process. Seasonal rates are due the first half by or before May 1st and the second and final installment by or before June 30th. Reservations can be made by phone or by printing and mailing in the required forms supplied online at the campground's website which is www.nicolettrailcampground.com.

Cancellations:

No refunds will be made unless cancellation takes place **seven days** prior to your scheduled date of arrival.

Check In/Out Times:

Check in time is 2 p.m. Check out time is 11:00 a.m. There is a full day charge if you are not checked out by the check out time. We will try to accommodate earlier arrival times, but there are no guarantees.

Speed Limit:

The speed limit within the campground is **5 mph** for any and all motorized vehicles.

Care & Courtesy:

Quiet hours are from 10pm to 7am. This will be monitored by the city's police dept. Respect the privacy of other campers. No wandering through occupied sites or private properties. Fires are not to be left unattended. Fires must be within the firepit only and completely extinguished with water before you leave. The firepit must be clean and no burning of garbage or recyclables. No form of fireworks, including sparklers are allowed in the campground. Do not dispose of cigarette butts on the ground. Please use firepits.

Dump Station:

Registered campers have free use of the dump station.

Office Hours:

Office hours for the campground are Monday through Friday, from 8:30 a.m. to 3:30 p.m. Friday Memorial Day –Labor Day 8:30 am –Noon. The office is located at City Hall, 150 N. McKenzie Ave. Contact 920-855-2255. If after hours, please fill out registration form located at the campground.

Before You Leave:

Please police your site for all garbage, cigarette butts, etc. before you leave. If we have to clean up your site, you will be billed. Please leave the site cleaner than you found it.
